

CONSTRUCTION TRAINING FUND’S ELIGIBILITY GUIDE

<b>Residential construction</b> is defined in the regulations as: <ul style="list-style-type: none"><li>Construction work on or resulting in a building that is intended to be used predominantly for residential purposes.</li></ul>	<b>Commercial construction</b> is defined in the regulations as construction work that: <ul style="list-style-type: none"><li>is not engineering work; or is carried out on, or results in, a rigid fixed structure that is intended predominantly for the use of, or to contain:</li><li>people</li><li>plants</li><li>machinery</li><li>goods</li><li>livestock.</li></ul>	<b>engineering construction work</b> means construction work on or resulting in — <div><div>a) a road, railway, airfield or other structure for the passage of persons, animals or vehicles; or</div><div>b) a breakwater, dock, jetty, pier, wharf or other structure for the improvement or alteration of any harbour, river or watercourse for the purposes of navigation; or</div><div>c) any structure for the storage or supply of water or for the irrigation of land; or</div><div>d) any structure for the conveyance, treatment or disposal of sewage or of the effluent from any premises; or</div><div>e) a structure for extracting, refining, processing or treatment of heavy industry materials or for the production or extraction of heavy industry products and by-products from materials; or</div><div>f) a bridge, viaduct, aqueduct or tunnel; or</div><div>g) a chimney stack that is not part of a residential or commercial building, a cooling tower, drilling rig, gas holder or silo; or</div><div>h) a pipeline; or</div><div>i) a navigational light, beacon or marker; or</div><div>j) a structure for the drainage of land; or</div><div>k) a structure for the storage of liquid or gas; or</div><div>l) a structure for the transmission of wireless or telegraphic communications; or</div><div>m) a fence, other than a fence on a farm; or</div><div>n) a grandstand, stadium or swimming pool; or</div><div>o) a structure for the generation, supply or transmission of electric power;</div></div>

The Act refers to the [Construction Industry Portable Paid Long Service Leave Act 1985](#) in outlining the meaning of ‘construction work’ to which the levy applies. ‘Construction work’ means the processes - (a.) of carrying out on a site the construction, erection, installation, reconstruction, re-erection, renovation, alteration, demolition or maintenance \* of or repairs to any of the following:

Employees

For full eligibility (ability to claim for all types of courses) the employee must demonstrate their work on the eligible site to be:

- An onsite construction, installation and / or fabrication activity;

For OH & S courses only, the employee must demonstrate their work on the eligible site to be:

- An Inspecting or Surveying activity e.g. Engineer, Architect, Draftsperson
